Documents like the Universal Declaration of Human Rights, the International Covenant on Civil and Political Rights, and the Declaration on the Elimination of All Forms of Intolerance and Discrimination Based on Religion or Belief address these issues. The World Conference on Human Rights presents an opportunity to evaluate our progress and the effectiveness of UN human rights instruments in protecting freedom of religion globally.

It's important to note that 1993 marks the 25th anniversary of the 1968 Conference on Human Rights in Tehran, as well as the 100th anniversary of the World's Parliament of Religions held in Chicago in 1893, which marked the beginning of greater cooperation among religious leaders. Additionally, religious non-governmental organizations have collaborated with the United Nations Economic and Social Council to prepare for the 1995 celebration of the International Year of Tolerance. Those of us working with the Non-Governmental Organizations Committee on Freedom of Religion or Belief and attending the World Conference on Human Rights are firmly convinced that religion need not divide the world. On the contrary, we believe that religious teachings can help eliminate religious intolerance. All spiritual traditions share principles that promote peace, understanding, and reconciliation. We believe religious communities have a special responsibility, rooted in their teachings, to dissolve divisions, end conflicts, and establish trust and security.

Religions all promote love, and this principle is central to human well-being. Intolerance stands in opposition to this principle and harms the common good. Many governments and global organizations have adopted policies to promote religious tolerance and protect the rights of minorities. Key examples include:

- The United Nations' Universal Declaration of Human Rights (Article 18) on religious freedom.

- The European Union's approach to religious pluralism.
- The role of the U.S. State Department's Office of International Religious Freedom.
- These policies underscore the importance of legal protections for religious freedom and tolerance across nations.

Intolerance often arises from cultural and historical tensions tied to religious traditions. Since such antagonisms stem from ignorance and limited understanding, education can reveal the shared spiritual values among various beliefs, thereby fostering tolerance. Therefore, education should focus not only on providing accurate information but on helping individuals appreciate diverse beliefs. School curricula should include the study of human rights declarations and the comparison of scriptures from different religions. This will uncover shared ethical values and help foster an appreciation for the importance of tolerance.

Nation-states also play a key role in promoting religious tolerance and cooperation. We urge those participating in the World Conference on Human Rights to recognize the urgent need to address conflicts, discrimination, and violence arising from religious intolerance. To be truly effective, the resources of the United Nations and non-governmental organizations must be combined with the political will of governments. Past negative experiences rooted in religious differences should be acknowledged, but efforts must be made to break the cycle of retribution to achieve lasting peace.

We recognize the important work done by the Human Rights Committee in drafting the General Comment on Article 18 of the International Covenant on Civil and Political Rights, and we urge all states to respond effectively to this initiative. The contributions of the UN Special Rapporteur on the Implementation of the Declaration on the Elimination of All Forms of Intolerance Based on Religion or

Belief are invaluable, and we call for the continuation and strengthening of this work. Despite progress, challenges remain in achieving full religious tolerance and cooperation. Key issues include:

- Religious extremism and radicalization.
- Discrimination against religious minorities.
- Political manipulation of religious sentiments.
- The impact of secularism on religious expression.

Addressing these challenges requires a multifaceted approach involving education, legal protections, and open dialogue. To enhance religious tolerance and global cooperation, the following strategies should be considered:

- "Education and Awareness": Incorporating religious tolerance into school curricula to promote mutual understanding.
- "Legal Protections": Strengthening legal frameworks at both national and international levels to protect religious freedoms.
- "Media Representation": Promoting balanced and respectful depictions of religious communities in the media.
- "Diplomatic Efforts": Strengthening intergovernmental cooperation to support religious harmony initiatives.
